Stakeholder Meeting on FFP's Second Food Aid and Food Security Assessment: July 24

FFP commissioned the Food and Nutrition Technical Assistance (FANTA) Project to undertake the second Food Aid and Food Security Assessment (FAFSA-2). The aim of FAFSA-2 was to document the overall achievements of Title II development programs during the period from Fiscal Years 2003-2009. The assessment, carried out by Roberta Van Haefen, Mary Ann Anderson, Herbert Caudill and Eamonn Kilmartin, examined 101 programs in 28 countries to identify approaches adopted and results achieved in principal Title II technical sectors along with promising practices, innovations, lessons learned, strengths, weaknesses, and constraints to achieving results.

FANTA-III in partnership with TOPS, are hosting a stakeholder meeting on July 24 from 9AM-5:30PM in Washington, DC to present the overall results, and invite community discussion on selected recommendations. Deadline Approaching: PCI's Small Savings-Big Impact Workshop, September 19-21, Addis Ababa, Ethiopia

PCI, with funding from a TOPS micro grant, is organizing a three-day, practitioner-driven event to build the capacity of participants to implement cost-effective and locally viable practices to reduce food insecurity through the implementation of successful "Village Savings and Loan" (VSL) methodologies. The event will bring together 60 participants from across Ethiopia and Eastern Africa to promote learning on 'what works' in terms of VSL methods and reducing food and nutrition insecurity. Rather than a PowerPoint presentation-dominated event, this forum will be a unique, practical, and hands-on experience, with energy and commitment visibly apparent among the mostly field-based participants.
